### **OPEN SESSION**

### Agenda Item 1 – Call to Order / Roll Call / Establishment of Quorum

The meeting was called to order at 10:00 a.m. by Chair Villegas. Executive Officer (EO) Andy Foster called roll. Chair Villegas, Commissioner Fiore, Commissioner Gruwell joined via video conference. A quorum was established.

### Agenda Item 2 - Welcome – Commission Chairman's Opening Remarks.

Chair Villegas welcomed everyone to the last meeting of 2024; he recapped on the great year the Commission had and the approval of Bare-Knuckle Fighting Championship. He thanked the Commissioners on all their work on building and strengthening the Commissions tribal relationships.

Vice Chair Williams added that he was great to have Chair Villegas back. He informed the Commission that California boxer, Israel Vazquez recently passed away after a battle with cancer.

#### Agenda Item 3 - Review and Possible action to approve the September 9,2024 Commission Meeting Minutes.

Chair Villegas presented the September 9, 2024, Commission meeting minutes for approval.

Commissioner Gruwell **moved** to approve the meeting minutes.

## Commissioner De Mars **seconded** the motion.

Commissioner Dr. DeMars asked whether the Commission received the headgear data mentioned in the previous meeting. EO Foster stated the Commission has received some of the headgear data.

#### No Public Comments.

The motion **passed** 6-0 by roll call vote. Chair Villegas **abstained**.

# Agenda Item 4 - Review and Possible action to approve the October 11,2024 Special Commission Meeting Minutes.

Chair Villegas presented the October 11, 2024, special Commission meeting minutes for approval.

Commissioner Gruwell **moved** to approve the meeting minutes.

Commissioner Fiore **seconded** the motion.

#### No Commissioner or Public Comments.

#### The motion passed 6-0 by roll call vote. Chair Villegas abstained.

#### Agenda Item 5- Review and Possible action to approve the Proposed 2025 Commission meeting dates.

Chair Villegas presented the proposed 2025 Commission meeting dates, they are as follows:

Commissioner Wetch proposed for the first meeting of 2025 to be January 20, 2025, after the UFC so that industry people in the area would be able to attend in person. Chair Villegas agreed with Commissioner Wetch's proposal if the January 20<sup>th</sup> date worked for all the Commissioners.

Commissioner Gruwell **moved** to approve the proposed 2025 meeting dates and moving the March 3, 2025, meeting date to January 20, 2025.

Commissioner Fiore **seconded** the motion.

No Commissioner or Public Comments.

The motion **passed** 7-0 by roll call vote.

# Agenda Item 6 - Discussion and Possible Action on Petition to Change the Decision for James Porter vs Angel Ramirez bout on June 15, 2024, in Pauma Valley, CA.

On June 18, 2024, the Commission received a petition to change a decision from Richard Falcon on behalf of James Porter. The bout occurred at the Pauma Casino in Pauma Valley on June 15, 2024. The bout ended by TKO referee stoppage from strikes at 1:30 of round 1. EO Foster stated that the head contact was incidental and happened during the process of a legal move. EO Foster recommended that the Commission uphold the decision of Referee Leben.

#### **Commissioner Comments**

Commissioner De Mars stated that she watched the video several times and frame by frame, she was not able to see clear enough that there was any deliberate contact. She stated that without being able to clearly see the contact, then she would go with the referee's decision.

Petitioner James Porter stated that he believes the bout should be overturned to a no contest as the head contact was an incidental and accidental headbutt and was not a legal strike.

Referee Leben stated that there was some head contact, but it was accidental by both contestants. He stated that is looked like Mr. Ramirez was dropping his head down and to the left to go in for a double leg takedown. He added that Mr. Porter's actions of sprawling and bringing his chin down onto the back of Mr. Ramirez's head is what caused the accidental clash of heads. Referee Leben added, that in addition to the head contact, there was also several blows landed by Mr. Ramirez on the ground after the accidental clash of heads.

Chair Villegas added that Referee Leben was concerned about the strikes on the ground which is what led him to stop the bout.

Mr. Porter agreed that he was dropping his head at the same time Mr. Ramirez's head was coming up. He stated that the damage was done from the headbutt and that he "came to" during the ground and pound.

Commissioner Wetch **moved** to deny the petition to change decision and accept the *Executive Officers recommendation*.

#### Commissioner De Mars **seconded** the motion.

#### Public Comments.

Richard Falcon with Mr. Porter asked if the decision was that the incidental headbutt was not what caused the fight to be stopped but that it was the strikes that were delivered afterwards when Mr. Porter fell to the ground.

EO Foster stated that was what Referee Leben called and unless clear and compelling information is presented to the Commission then the referees' decision would stand.

Commissioner De Mars asked if all the parties were agreeing that the head contact was accidental? She added that the rule states: the *head may not be used as a striking instrument in any fashion.* Commissioner De Mars stated that even if the athlete runs into the other athletes' head, then the head is not being used as a striking instrument and that the referee made the right call.

#### No further Commissioner or Public Comments.

#### The motion **passed** 7-0 by roll call vote.

Chair Villegas thanked Mr. Porter for coming onto the call.

# Agenda Item 7 – Review, Discussion, and Possible Action regarding the July 26, 2024, Arbitration Order and demand for purse withholdings pursuant to California Business and Professions Code § 18856(b).

On February 5, 2024, the Commission received an arbitration request from licensed manager Rick Mirigian regarding a dispute with boxer Arnold Barboza Jr. concerning the Commission approved Boxer-Manager contract M-2021-0001. EO Foster stated that he attempted to settle the arbitration but was unable to, he added that he recused himself as the arbitrator and appointed Assistant Chief Athletic Inspector Sean Wells. All parties, their attorneys and witnesses were present for the June 13, 2024, teleconference arbitration. At the conclusion of the arbitration hearing, Mr. Wells rendered a decision and order that became effective on July 26, 2024. The arbitration order for purse withholding was sent to the New York Commission, they did not withhold the funds from the purse. Mr. Barboza then went onto to fight in Saudi Arabia, the event was regulated by the Mohegan Sun Athletic Tribe. The order for the purse withholding was sent to the Mohegan Sun Athletic Tribe, they were under no obligation to honor the arbitration, but they did and withheld the requested amount of \$40,875 from Mr. Barboza's purse. Mr. Barboza and his attorney requested a hearing before the Commission regarding the purse withholding and arbitration order.

Mr. Gallegos, the attorney for Mr. Barboza stated the fight happened in Saudi Arabia, which the Commission didn't have jurisdiction over as the fight was regulated by the Mohegan Sun Commission. Mr. Gallegos stated that the Commission was not allowed to enforce the arbitration as it was not a final judgement order and collection by the Commission exceeded their authority. Mr. Gallegos argued that all of the required circumstances were not met in order for the Commission to withhold the funds from the purse and that the Commission does not hold the power to collect the funds.

Mr. Gardner with the Attorney General's office stated that is it important for the Commission to understand that the references to the code of civil procedures that Mr. Gallegos referred to are in relation to the California Arbitration Act, which is judicial arbitration, and this was a completely separate type of arbitration. This arbitration was pursuant to BPC 18856 under the authority given to the Commission; the arbitration order given was final and binding. Mr. Gardner stated that in respect to the withholding of the funds from the purse, the order stated the total Mr. Barboza was to pay to Mr. Mirigian, how those payments were to be made, and the total Mr. Barboza was to pay to the Commission for cost recovery. Mr. Gardner added that EO Foster was well within his authority to enact the order for withholding per the final arbitration order.

Mr. Gallegos stated that Mr. Barboza hadn't violated any order, rule, or provisions therefore the Commission didn't have the authority to withhold the purse amount.

Mr. Gardner reiterated that the failure to comply with the order by not paying the cost recovery to the Commission by the time it was due was a violation of rule 390. He added

that the fighter-manager contract, which was on a Commission approved form, gives the authority and jurisdiction to the California Commission regardless of where the fight(s) are held.

Legal Counsel, Mr. Swenson asked Mr. Gardner if his office had received a written memorandum of points and authority from Mr. Gallegos. He stated that his office had not. Mr. Swenson stated that the petitioner did not provide any materials to be included in the meeting materials for the Commission to review.

Commissioner Wetch asked Mr. Swenson, in the history of the Commission how many arbitration awards has the Commission overseen the collection of? Mr. Swenson answered that the Commission has overseen hundreds of arbitration decision. Commissioner Wetch asked if this was setting any precedent? Mr. Swenson stated that the decision on the arbitration award is not precedential unless deemed so by motion or resolution.

Commissioner Gruwell **moved** to uphold the arbitration decision that was rendered and immediately release the check that the Commission received on November 26, 2024, in the amount of \$40,875 to manager Rick Mirigian.

Commissioner De Mars **seconded** the motion.

#### **Public Comments**

Greg Smith, counsel for Mr. Mirigian, added that Mr. Gallegos made the argument that this step was being taken ahead of a breach of the order, but the order required payment to be made within 72 hours of the bout and payment was not made by Mr. Barboza. Additionally, Mr. Mirigian was ordered to pay cost recovery to the Commission, and he did so within the required timeframe.

#### No further Commissioner or Public Comments.

The motion **passed** 7-0 by roll call vote.

#### <u>Agenda Item 8 – Discussion and Possible Action to approve the Commissions 2025</u> <u>Rulemaking Calendar.</u>

EO Foster presented the 2025 Rulemaking Calendar that is required by the Office of Administrative Law.

Commissioner De Mars **moved** to approve the Rulemaking Calendar.

Commissioner Fiore **seconded** the motion.

#### <u>Agenda Item 9 – Discussion and Possible Action on the appointments of the</u> members to the Advisory Committee on Medical and Safety Standards (MAC).

EO Foster informed the Commission the terms of the current Advisory Committee on Medical and Safety Standards (MAC) members expired, and they need to be re-appointed. EO Foster recommended re-appointment of the following members:

- Diego Allende, D.O
- Rhonda Rand, M.D
- Jonathan A. Schleimer, M.D

EO Foster recommended appointment of Dr. Gary Furness as a new member, replacing Dr. Brian Estwick who has since retired. Curriculum vitae for all physicians was included in the meeting materials.

Commissioner Gruwell **moved** to approve the proposed six (6) members to the Advisory Committee on Medical and Safety Standards.

Vice Chair Dr. Williams seconded the motion.

#### No Commission or Public Comments.

The motion passed 7-0 by roll call vote.

### <u>Agenda Item 10 – Discussion and Possible Action on purchasing malpractice</u> <u>insurance coverage for California Ringside Physicians.</u>

EO Foster stated that the malpractice insurance would be supplemental coverage. He added that based on new developments and legal counsel, John Kinn's discussion with the insurance company, his position had changed. He added that with the application of Business and Professions Code18735, the immunity statue, that he would like to look into the matter further.

Vice Chair Dr. Williams stated that the Commission needed to continue to ensure that the ringside physicians are protected, and that they feel confident when working at events. He added to EO Foster has made this an absolute priority.

Chair Villegas asked EO Foster to gather more information about this and report back to the Commission at a later date.

#### Agenda Item 11 – Executive Officer's Report

# a. Recognition of boxing referee Jack Reiss for his contribution to professional boxing.

Referee Jack Reiss was presented with a certificate of recognition by the Commission, it read as follows:

The California State Athletic Commission congratulates you on your retirement after 25 years as a professional boxing referee. During those 25 years, you were the third man in the ring for 1,152 bouts, officiating both championship bouts and champions in the making. Your impressive resume spans decades and includes some of boxing's most memorable bouts such as Andre Ward vs. Edwin Rodriguez, Leo Santa Cruz vs. Abner Mares, Vasyl Lomachenko vs. Gary Russell Jr., Cecelia Braekhus vs. Aleksandra Magdziak Lopes, Deontay Wilder vs. Tyson Fury I, Errol Spence Jr. vs. Shawn Porter, and Israil Madrimov vs. Terence Crawford.

Your leadership and mentorship have proven invaluable to referees in California as well as the world. The Commission thanks you for your commitment to the sport of boxing and looks forward to your new chapter as a boxing judge.

EO Foster, Chair Villegas, Commissioner De Mars, Commissioner Wetch, JT Steele, and Referee Tom Taylor all gave statements regarding Jack's contribution to boxing.

Referee Reiss thanked the Commission for the recognition. He stated that being a referee was not only a privilege but was also a calling. Mr. Reiss thanked EO Foster, Chief Inspector Relyea and Assistant Executive Officer Blackstock. He also acknowledged former Chair Frierson and retired official John McCarthy for their mentorship. He thanked all of the Commissioners that have been to the dressing rooms to listen to his pre-fight instructions. Mr. Reiss went on to formally acknowledge and thank other officials, inspectors, and commissioners for all of their hard work and dedication to the sport of boxing. He added that he what will miss most from being a referee will be "taking that 100-yard walk to the ring".

# b. Recognition of legal counsel Kenneth Swenson for his work with the Commission.

Legal counsel Kenneth Swensen was presented with a certificate of recognition by the Commission, it read as follows:

The California State Athletic Commission congratulates you on your retirement after more than 12 years of service the State of California. During your time as general counsel to the Commission your expertise, advice, and insight on regulatory compliance, dispute resolution, licensing, and litigation was a valuable asset to the Commission. Your insight was crucial in ensuring that the Commission operated within legal boundaries while promoting fair play and safety for athletes The Commission extends its best wishes on the occasion of your retirement and commends you on your outstanding record of state service.

EO Foster, Chair Villegas, and Commissioner De Mars all gave statements regarding Ken's work with the Commission.

Mr. Swenson stated that it had been a real honor to work with one of the most outstanding Commissions in the world. He added that working the Commission has meant a lot to him and made his professional career rewarding. He added that the Commission was blessed to have one of best executive officers in world.

### c. Budget Update for the Support Fund, the Neurological Fund, Pension Program and MMA Benefit Fund.

EO Foster stated that the Commission has deposited \$850,646.48 to the support fund as of November 21, 2024. He added that the support fund is slightly below of where he would like the Commission to be at but felt confident that it would be made up based on the event schedule.

The Commission has deposited \$36,426.00 into the boxer's pensions fund and \$20,236.96 into the MMA pension. The pension investment account is currently at \$4.709 million as October 31, 2024.

EO Foster informed that Commission that he had a meeting with the Office of Public Affairs on November 4, 2024, to review the marketing materials and potential layout of the website. A copy of the documents was included in the meeting materials for the Commissioners to review. He thanked the Department for all of their work on this.



At the December 9, 2023, Commission meeting, the Commission approved Bare Knuckle Fighting Championships (BKFC) request for a Promoters license to allow them to hold one event using BKFC rules as part of a pilot program and to allow the executive officer the option grant approval to hold three additional events. After the conclusion of the one event a report was provided to the Commission on the event held, since the event had no issues approval to hold three additional events was given.

Bare Knuckle Fighting Championship (BKFC) is requesting that the Commission approve them for a Promoters' license in order to continue to hold events using Bare Knuckle Fighting Rules. Bare Knuckle Fighting Championship promoted four events under their temporary license:

- April 27, 2024-Peacock Theater, Los Angeles, this event had 12 bouts.
- July 12, 2024- Pechanga Resort and Casino, Temecula, this event had 10 bouts.
- November 23, 2024- Thunder Studios, Long Beach, this event had 10 bouts.
- January 18, 2025- Pechanga Resort and Casino, Temecula, this event had 9 bouts.

Full event results and suspensions from the four events are included in the meeting materials for review.

#### **Recommendation**

I recommend that the Commission approve Bare Knuckle Fighting Championships' request for a Promoters' license and to require them to come before the Commission on annual basis for review.

#### **Background**

On March 24, 2014, the Commission notified USA Boxing that they would be required to have an ambulance staffed with a paramedic at all USA Boxing events. USA Boxing was required to be in compliance with this by June 1, 2014. Prior to 2014, the Commission had issued USA Boxing a wavier for the ambulance requirement; this wavier had been in place for decades. USA Boxing has been in compliance with the ambulance requirement for all the events held in California.

Even though the number of local boxing clubs (LBC) in California has increased, each local boxing club is holding less events per year as the cost for the ambulance is a significant expense. USA Boxing events have a high safety track record; the number of events, injuries and suspensions are reported to the Commission in their quarterly report.

USA Boxing has provided a memo regarding ambulance usage at events and their emergency action protocol for the Commission to review.

#### **Recommendation**

I recommend that the Commission grant USA Boxing a wavier for the ambulance requirement at events that have less than twenty bouts; the waiver should be granted on an annual basis with review and approval being completed at the first Commission meeting of each year.

#### State of California

#### BUSINESS AND PROFESSIONS CODE

#### Section 18646

18646. (a) This chapter applies to all amateur boxing, wrestling, and full contact martial arts contests.

(b) The commission may, however, authorize one or more nonprofit boxing, wrestling, or martial arts clubs, organizations, or sanctioning bodies, upon approval of its bylaws, to administer its rules for amateur boxing, wrestling, and full contact martial arts contests, and may, therefore, waive direct commission application of laws and rules, including licensure, subject to the commission's affirmative finding that the standards and enforcement of similar rules by a club, organization, or sanctioning body meet or exceed the safety and fairness standards of the commission. The commission shall review the performance of any such club, organization, or sanctioning body annually.

(c) Every contest subject to this section shall be preceded by a physical examination, specified by the commission, of every contestant. A physician and surgeon shall be in attendance at the contest. There shall be a medical insurance program satisfactory to the commission provided by an amateur club, organization, or sanctioning body in effect covering all contestants. The commission shall review compliance with these requirements.

(d) Any club, organization, or sanctioning body that conducts, holds, or gives amateur contests pursuant to this section, which collects money for the event, shall furnish a written financial report of receipts and disbursements within 90 days of the event.

(e) The commission has the right to have present without charge or restriction such representatives as are necessary to obtain compliance with this section.

(f) The commission may require any additional notices and reports it deems necessary to enforce the provisions of this section.

(g) The commission, at its discretion, may rescind previously approved authorization of a nonprofit boxing, wrestling, or martial arts club, organization, or sanctioning body to administer its rules for amateur boxing, wrestling, and full contact martial arts contests.

The club shall also ensure that there is adequate access, as determined by a commission representative and a ringside physician on a case-by-case basis, for a medical evacuation should that become necessary.

USA Boxing and the California State Athletic Commission considers the health and safety of our athletes as our number one priority. As such, California State Athletic Commission regulations require all USA Boxing sanctioned events to have emergency services on site. We appreciate the intent of this statute, as it adds an element of safety. However, many USA Boxing event holders, who operate local, community gyms, find this requirement cost prohibitive, making it difficult to provide competition opportunities to their communities.

In 2024, USA Boxing sanctioned 187 local boxing events in California, which contested over 5,100 bouts. Of those, 18 medical restrictions were issued (0.0033%) with 1 boxer reported needing ambulance transport. It should be noted the onsite ambulance would not transport the boxer/patient, so an offsite ambulance was called to transport. Please consider the following data for the commission's discussion of this regulation and to illustrate USA Boxing's confidence in its provisions toward athlete safety.

#### 1. EMS Cost and Usage

USA Boxing reviewed medical restriction data between January 2023 – February 2025, along with consulted with leadership of each LBC, to obtain the following data regarding the number of boxers transported by ambulance since 2023 and their cost:

#### 2. Training

USA Boxing events must be overseen by officials who undergo hours of specialized training. This certification course is called the *Official in Charge (OIC)* certification. Our officials in charge (OICs) are tasked with various responsibilities to ensure a smooth event. In respect of this proposal, we would like to highlight two specific responsibilities:

#### Pre-bout Responsibilities

The OIC is required to take inventory of various items and/or information, in the event of an emergency. Some of those responsibilities are:

- To collect and distribute all pertinent event data to staff, to provide dispatchers in case of emergency.
- A list of the four nearest medical facilities, with contact information.
- Designation of roles and responsibilities of staff in the event of an emergency (who calls 911, who assist the physician, crow control, etc.).
- To provide USA Boxing national office emergency contact information.
- Ensuring the venue is properly equipped with all necessary safety equipment, as required by USA Boxing's rules.

The remaining responsibilities can be found in the *Official in Charge* certification packet, accompanying this document.

#### Emergency Response

In the event of a severe injury or matters of public safety, the OIC is trained to recognize the incident and support as needed. This document will focus on how officials are trained to support

USA Boxing assigns roles for the ringside physician and officials working the event, creating an "Emergency Team." Designation of these roles in advance minimizes having to do so during an emergency, increasing valuable response time. Below is a brief description of each team member.

- Emergency Team Leader (Ringside Physician):
  - The physician will attend the affected party and begin their assessment. If more than one physician is present, it will be the physician closest to the incident.
- Ring Assistant(s):
  - This will be the referee assigned to the bout. They will assist the physician, as directed.
- 911 Contact:
  - The person assigned to call 911 and escort emergency personnel to the scene of the emergency.

- Crowd Control:
  - Individual(s) or security agency responsible for maintaining calm and order among attendees
- AED Operator (optional):
  - In a cardiac emergency, the assigned emergency team member will retrieve the AED, prepare it for use and follow direction of the physician or the AED Device. NOTE: This role will be delegated to EMS services, if available.

#### 2. USA Boxing Rules and Regulations

For the health and safety and safety of our athletes, USA Boxing enforces the following rules at all USA Boxing sanctioned events:

#### **Competition Equipment Certification:**

USA Boxing events require the use of USA Boxing certified equipment. Our certification process, performed by Wayne State University, verifies all competition equipment meets USA Boxing's rigorous safety standards. In addition, manufacturers of USA Boxing approved equipment provide insurance in the event of a loss due to defective equipment.

#### <u>Headgear</u>

All USA Boxing sanctioned events require the use of headgear.

#### <u>Gloves</u>

USA Boxing assigns participants' glove size by weight, allowing up to 16 oz gloves. For boxers who weigh less than 143 lbs., 10 oz, 12 oz, and 16 oz gloves may be used. For boxers who weigh more than 143 lbs., we restrict the use of gloves to 12 or 16 ounces. This variance allows USA Boxing to better tailor the size of the gloves to the competitiveness and output of the boxers, mitigating injury.

#### 3. Injury Data

USA Boxing athletes experience a low rate of injury, compared to participants in other sports. To illustrate this, we included data comparing USA Boxing national event injury data (2017 – 2019), to a study conducted by the American Association of Pediatrics (2000) surrounding juvenile injury rates in other youth sports. USA Boxing finds the limited potential for incidental contact combined with the safeguards listed above yield a lower injury rate. The data is attached to this document.

compares the injury rates in Olympic-style boxing between 2017 – 2019, compared to the most popular common youth sports, as of 2000. The data breaks down as follows:


1 – Overall Data: This section illustrates each sport, the total number of participants, and number of overall injuries incurred during participation.

2 – Injuries Per 10 Participants: This illustrates the number of injuries occurred per 10 participants. To put it into context, this translates to 5 boxing matches, or nearly one full soccer team (a soccer team fields 11 players).

3 – Number of Exposures per 1 Injury: This the number of times someone participated in a particular sport before incurring a specific injury.

4 – Probability: The likeliness a participant suffers an injury. This was calculated by taking 1 and dividing it by the injury data in section 3 (i.e. boxers experience 1 concussion for every 368 exposures, 1/368.85 = .00271 or .271%)

\* - Boxer ages ranged from 8 years old - 82 years old. All other sports, ages 10 - 19.

Good afternoon members of the California State Athletic Commission,

Thank you again for your time. Since our original submission, USA Boxing received additional information specific to the two instances involving EMS transport, cited in our original submission. Considering the pending discussion, we find it paramount for the commission to have this information.

The first instance occurred between 2014 and 2017 in the Southern California LBC. It was unknown whether the individual was an athlete (competitor) or non-athlete member of USA Boxing. He was transported due to a knee injury. The second instance took place in 2024, also in Southern California. This was for a USA Boxing registered official who suffered a heart attack.

Furthermore, USA Boxing reviewed additional archives and declares it only utilized two EMS transports since 2014.

As the commission facilitates discussion over this matter, we would like to formally request the commission for a variance or modification to relax this requirement of USA Boxing. USA Boxing and CSAC make athlete safety their number one concern. We are confident the information provided will make that evident.



### I. Introduction

Boxing carries the stigma of being a highly dangerous sport. USA Boxing prides itself on debunking that stigma through a provision of rules designed to prevent injury, while preserving the safety of our boxers, coaches, officials, employees, and shareholders.

The chart to the right compares the injury rates between boxing and the more popular non-combative sports. Boxing reported less than one injury for every ten participants. The next safest sport was baseball, with four injuries per every 10 participants.

The rules implemented in Olympic-style boxing

have a positive impact on reducing injuries and minimizing the number of critical incidents that occur during competition. Despite the minimal number of critical incidents USA Boxing experienced over the years, it only takes one critical incident to have a lifelong impact.


USA Boxing works constantly on developing protocols to assist our members in the event of an emergency. To accomplish that goal, USA Boxing developed this guide to train Officials-in-Charge (OIC) and event staff on executing the appropriate protocols in the event of an emergency. We owe it to our members to demonstrate their safety is of the utmost concern.

#### Why It Is Important

This training was developed out of necessity in meeting our goal of keeping members safe. In an emergency, there is an immediate change to the feel of the event. There is much to process physically, emotionally, and psychologically, to the point where some people have walked away from the sport. We recognize it's equally important to preserve the mental and emotional health of our members, as we do their physical health.

In recent years, Post Traumatic Stress Disorder (PTSD) has become more prevalent in our handling of critical incidents over the last few years. In August 2020, the American Psychiatric Association reported 11.4 million people in the United States suffer from a form of PTSD every year.

#### The Cycle of Anxiety

#### A Anxiety

An anxiety-producing situation leads to uncomfortable symptoms such as worry, fear, a racing heart, sweating, or a feeling of being overwhelmed.

#### 🗯 Avoidance

Uncomfortable symptoms are controlled by avoiding the anxiety-producing situation. Examples of avoidance include:

- Skipping class to avoid giving a presentation
- Using drugs or alcohol to numb feelings
- Procrastinating on challenging tasks

#### Short-Term Relief from Anxiety

Avoidance of the anxiety-producing situation gives an immediate sense of relief. The symptoms of anxiety lessen, but only temporarily.

#### Long-Term Anxiety Growth

The fear that initially led to avoidance worsens, and the brain learns that when the anxietyproducing situation is avoided, the symptoms go away. As a result, the symptoms of anxiety will be worse the next time, and avoidance is more likely.

It is common for a traumatic event to accompany a form of anxiety. The image above illustrates the cycle of anxiety and how repressed trauma can have a lifelong impact. We ask if any USA Boxing member, spectator, or shareholder is experiencing trauma or related mental health ailments, that they speak with a mental health professional as soon as possible.

Lastly, this plan demonstrates fiscal responsibility by allowing USA Boxing to negotiate insurance premiums more effectively. Every USA Boxing membership is afforded a secondary injury policy in the amount of \$25,000 per incident. Insurance companies calculate the cost of that policy based on statistical factors surrounding the risk and payout of a potential claim. By informing the insurance company of the development of this protocol, it decreases the risk of a claim and mitigates losses reported during an event, thus reducing the payout for a claim. The money saved on insurance can be reinvested into supporting our grassroot efforts, to improve the quality of our events, and help us serve our members better.

### II. Sanction Requirements and Administration

Effective January 1, 2023, USA Boxing required all sanctioned events to have an official who has successfully completed this training. This requirement reflects USA Boxing's commitment to safety and provides reassurance to those in attendance.

Also, to continue fostering a culture of transparency and equity, we prohibit sanction holders from also serving as an OIC at any event, as this is considered a conflict of interest.

USA Boxing is comprised of 57 unique LBCs, each with their own circumstances. We would like to take this opportunity to reinforce and empower our LBCs to ratify or amend local policy, based on said circumstances, to better implement this protocol for the betterment of their members.

### III. Event Management

#### The Emergency Checklist

The Emergency Checklist is designed to serve as a blueprint for sanction hosts and the official in charge to assist them in an emergency. Please reference USA Boxing's *Guide to Hosting a Successful Sanction*, for additional information on hosting an event.

The Emergency Checklist includes the following items below. These items are recommended to be reviewed prior to the event:

- Event information (time, date, address, the official in charge, etc.)
- Emergency services(EMS, EMTs, etc.)
  - Certain states require emergency services on site at every event.
     Please refer to your state's athletic commission for more information
- Hospital/emergency department information
  - Ensure the Official in Charge and ringside physician are aware of nearby medical facilities in the event of an emergency.
    - If necessary, have the ringside physician contact the nearest medical facility to inform them of any participants directed, or may have a reason to be directed, to their facility.
- Emergency Team Information
  - This includes the Emergency team roles and responsibilities.
    - Medical Team Leader (MTL) This is always the ringside physician.
      - The MTL will enter the ring in the event of an emergency.
      - If there is more than one physician, the one assigned to the injured boxer's corner will be designated as the MTL.
      - If an emergency occurs outside the ring, the physician closest to the incident will be the MTL.
    - 911 Contact This is the designated person to call 911 in the event of an emergency.

- It is recommended for the person calling 911 to become familiar with the questions they will be asked by a dispatcher.
- This person will also meet EMS and escort them to the emergency.
- AED Operator (optional) This person will retrieve and operate the AED, if a unit is available. Note: This role should only be assigned if EMS will NOT be present
  - Ensure the person who will use the AED is comfortable doing so. Instructions can be found HERE, if needed.
  - For help locating an AED, contact your local office of public safety.
- Crowd Control: A person/people designated to help maintain order amongst the participants at an event.
  - Certain circumstances may require a larger presence of control. Evaluate each event accordingly. Examples include, but are not limited to:
    - Highly competitive, higher stake bouts
    - Competition between rival boxers/clubs
    - Events with a large number of participants
  - Sanction hosts can delegate this task to a dedicated security agency.
- Ring Assistant (RA): The appointed referee is automatically assigned as the ring assistant.
  - Their role is to assist the physician in the treatment of the affected party.
  - For an emergency outside a sanctioned bout, the RA chosen will be at the discretion of the physician.
- A list of emergency team members and their assigned roles

#### What to Do Before the Event

The following set of procedures are to be performed by the sanction holder, OIC, and attending staff before the start of the event. This is best done by scheduling a "pre-event" meeting before the start of weigh-ins for the event. Please review the *OIC Checklist* for assistance with topics to discuss during the meeting.

- Ensuring the event and emergency checklist is complete. A copy of the event checklist will be included with this training. The Event Checklist is different from the Emergency Checklist.
- A walkthrough of the facility, noting all entrances and exits, along with any available emergency equipment (first aid kits, AEDs, fire extinguishers, etc).
  - If possible, have a map of where the aforementioned items are located, in the event of an emergency.
  - Refer to the diagram on the following page, as an example of the field of play, noting where the checklist can be found.
    - USA Boxing understands each location is different. The sanction holder and/or Official in Charge must work to arrange the field of play to best suit the needs of the event, the USA Boxing Rulebook, and safety of those in attendance.
- Ensure the ringside physician and/or OIC are aware of nearby hospitals/ emergency rooms in the event of an emergency.
- Verify the document is readily accessible increases accountability, allowing members to understand everyone's role on the team.
- Ensure copies of the checklist are readily available to all staff.




Figure 1: Emergency Checklist placement example

### IV. In the Event of an Emergency

#### Duties

In an emergency, it is critical for all emergency team members to begin enacting their assigned roles and collaborate care amongst one another immediately. Effective plan execution leads to a significant increase in survival rates.

The Emergency Team Leader will approach the affected party and begin their assessment.

• The person assigned to call 911 needs to report the emergency as soon as possible and assist dispatchers with as much real time information about the incident as possible. They may ask to meet and escort emergency personnel to the scene of the emergency.

Simultaneously, team members assigned to control the crowd may be called to act. This could mean:

- Deflecting people away from the site of the emergency, to allow the physician or first responders to provide the best possible care.
- Defusing attendees, to prevent an altercation.
- Directing people away from a dangerous situation ( an altercation or hazard)
- We do not want to risk the safety of anyone in attendance. If an incident or altercation cannot be managed safely or comfortably, contact the proper authorities immediately.

The referee will remain in the ring to serve as the Ring Assistant. Their role is to assist with any duties in the emergency, as directed by the physician.

In a cardiac emergency, the assigned emergency team member can retrieve the AED, prepare it for use and follow the direction of the physician. **NOTE: This responsibility will be delegated to EMS services, if on site.** 

### V. Incident Resolution

#### Reporting

Once the scene is under control, contact Mike McAtee, <u>immediately</u>.

The reporting party and other witnesses may be asked to complete the critical incident form.

• The report can be completed online by clicking the link below *OR* by using a smartphone and taking an image of the QR code located on the checklist.

#### Critical Incident Online Reporting Form

• A paper copy can also be completed and turned into the national office. Instructions will be provided. To report a liability and/or injury claim, contact Lynette Smith and Claudia Douglas no later than 30 days from the date of the incident, as outlined in USA Boxing's insurance policy. Failure to do so could result in the denial of the claim. Contact information can be found below.

#### **Evidence Collection**

Once the scene is under control, it is imperative to collect as much evidence and information as soon as possible. Insurance companies, law enforcement agencies, first responders, and other responsible parties may request information for their processes.

Plus, this mitigates fault and liability towards USA Boxing and their representatives, in the event of a lawsuit or other claim.

In the event of a critical incident, the Official in Charge or LBC administrator is required to collect and prepare the following items, when available:

- Boxing Gloves (both boxers)
- Headgear (both boxers)
- Gloves worn by the referee assigned to the bout.
- Anything else requested by USA Boxing

#### **Evidence** Preparation

To best preserve the state of the items, please prepare the items in the manner instructed below.

USA Boxing strongly recommends completing an evidence collection form. This ensures all items are properly inventoried and all information about the items are disclosed to USA Boxing, prior to shipment.

## Note: When collecting items of interest, please use paper bags, as they wick moisture and humidity to preserve the state of the item. Plastic and other materials are not breathable, which jeopardizes item integrity.

#### **Boxing Gloves and Headgear:**

- Collect the items for both boxers. Examine them for any notable blemishes or details important to the event. Once examined, the examiner will initial the loop strap of the gloves, or near the forehead of the headgear, with the date examined.
- Place each glove in its own paper bag, if possible. Otherwise, each pair can be packaged together. Staple the bag shut and on the outside of the bag note the following:
  - o Boxer's name
  - o Examiner's name
  - o Examination date
  - o Left or right hand

#### Referee Gloves:

- Take the referee's gloves and place them in a paper bag. Note the following on the outside of the bag or label:
  - o Referee's name
  - Examiner's name
  - Date of Examination
- It is not required for the examiner to sign the latex/nitrite gloves used by the official.

#### <u>Handwraps:</u>

• Place the wraps in a paper bag. Note the following on the outside of the bag or label:

- o Referee's name
- Examiner's name
- Date of Examination
- The examiner must initial each hand wrap.
- If possible, identify which hand the wrap was worn on.

#### <u>All Other Items:</u>

- Place the item in a paper bag.
- Note the following:
  - The item(s) examined.
  - Who the item belonged to.
  - Notable characteristics of the item.

Once all items have been examined and packaged, they will need to be shipped to the national office. The USA Boxing national office will provide a prepaid UPS label, via email, to the appropriate party.

For submissions that include various smaller items, it is appropriate to package all items in a larger paper bag, if possible.

#### **Debrief Procedures:**

Ideally, witnesses have been instructed to complete the critical incident form outlined earlier. If not, refer to pages 10 - 11 for instructions.

The OIC/LBC Leader will be designated to deliver completed critical incident forms to Mike McAtee via email, at mmcatee@usaboxing.org. If a person other than the OIC/LBC Leader will be designated to manage the critical incident forms, please notify the national office (LBCs will be asked to keep these documents for a minimum of 1 year.

Once USA Boxing receives the completed critical incident forms, USA Boxing will begin working with the appropriate parties to help mitigate any concerns of those impacted, starting with the parties at the center of the emergency.

#### Additional Support to Those Impacted

For those impacted, please direct that party to seek appropriate help from a licensed health professional as soon as possible.

The following resources are a great starting point to locate health services. For additional resources, we recommend calling 211 from your phone. Most cities dedicate this number as an essential community service line, which offer numerous resources, including mental health counseling.

- https://www.psycom.net/how-to-find-affordable-therapy/. This site is a great starting point to find numerous mental health services. Some of these services are free and incorporate a healthy balance of physical or virtual forms of service.
- Many employers offer EAP services to their employees, as part of their benefit package. EAP services offer a variety of mental and physical health services, which may include a limited number of free sessions. It's common for EAP plans to cover not only the policy holder, but their families as well.

If an official, or LBC board member's ability to perform their assigned duties is impacted, we ask they take the appropriate steps to seek assistance from a health professional. For those in a leadership position, please notify USA Boxing if this may involve a change in your involvement with USA Boxing.

To aid in transition and recovery, an official may work with their COO to discuss their level of participation and involvement.

### VI. Conclusion


In the event of an emergency, it is critical to have a well-executed protocol to ensure the utmost safety of those in attendance. USA Boxing strives to offer its members a safe and enjoyable environment in which to participate in.

In an emergency, remember the following steps:

- 1. Use the checklists to verify all is in order before the event.
- 2. Have everyone understand their role in the event of an emergency.
- 3. Report the emergency to USA Boxing.
- 4. Help USA Boxing by collecting as much information as possible.
- **5.** Utilize your resources (this material, the USAB Rulebook, COO Manual, etc.) whenever needed.
- 6. Exercise your best judgement to maintain the safety and wellbeing of <u>ALL</u> in attendance.
