### OPEN SESSION

#### Agenda Item 1-Call to Order/ Pledge of Allegiance/ Roll Call/ Establishment of a Quorum.

The meeting was called to order at 10:00 am by Chair Villegas. Executive Officer (EO) Foster call roll. A quorum was established. Commissioners Wetch and Hendrickson were absent.

#### Agenda Item 2-Welcome - Chairman's Opening Remarks.

Chairman Villegas stated that this was our 3rd meeting for the year, and it had been a very productive and very exciting year for the Commission and combat sports. He added that he would like to acknowledge all the small businesses across California that appreciate, embrace, and just love combat sports. He added that he would like to see if the Commission could come up with some type of certificate to show our appreciation for everything that they do to support combat sports across the state.

**Agenda Item 5-Discussion and Possible Action regarding Celebrity Boxing Promotions Request for a Promoter license in order to hold events pursuant to California Code of Regulations, title 4, section 533.**

This item was tabled.

**Agenda Item 6-Discussion and Possible Action regarding the Muhammad Ali American Boxing Revival Act (H.R. 4624).**

EO Foster stated H.R. 4624 has been introduced in Congress and this will be the first time in 25 years that federal legislation has been introduced at the federal level involving boxing. EO Foster went through the bill that was introduced into the House of Representatives by Representative Brian Jack (R-GA-3) and co-sponsored by Representatives Sharica Davids (D-KS-3) and Addison McDowell (R-NC-6). He added that the purpose of the act was to provide increased choice and opportunity to professional boxers by allowing a professional boxer the option to choose or participate in an alternative system offered by a Unified Boxing Organization (UBO). EO Foster stated that the UBO would have increased medical safety standards similar to California already requires and that the cost of the medical tests would be the responsibility of the UBO. EO Foster did point out that his bill does require that female boxers would have to submit negative pregnancy test results in order to compete. EO Foster pointed out that UBO events would require a minimum of two ambulances present at each event and a minimum of three ringside physicians present at each event. He added that the UBO would be required to provide support services for boxers under the UBO, the UBO is required to have equipment and facilities for training and rehabilitation. The UBO would have to ensure that the boxer has access to equipment and facilities that are operated by the UBO for training. He added that the act would also require an insurance policy for coverage during the training period. EO Foster pointed out that UBO's would also be required to have an anti-doping program but would be able to develop their own prohibited substance list. EO Foster emphasized that nothing in the proposed act would prohibit a state from adopting or enforcing supplemental laws or regulations not inconsistent with this section or criminal

civil or administrative finds for violation of such laws and regulations. EO Foster stated this act would also allow the UBOs to rank their own fighters and sanction their own title fights.

EO Foster then pointed out that the proposed act would also make changes that would affect professional boxers across the country. The act would require minimum medical standards that included an eye exam, blood work, and a physical exam. Additionally, this act would require a minimum of \$25,000 for medical coverage for any injury sustained at an event. The act would also establish a minimum pay per round for boxers of \$150. EO Foster stated that this minimum is less than what California has set but it is significantly higher than states are paying some of their lowest paid boxers. EO Foster then went through his PowerPoint presentation breaking down title fight pay in California, number of title fights per weight class in California and sanctioning body fees charged to promoters and boxers.

### ***Commissioner Comments***

Commissioner Dr. De Mars asked how far in advance would boxers signed to a UBO be notified when the prohibited substance list was changed? EO Foster stated that he would get that information.

Vice Chair Dr. Williams stated that it didn't appear that anything in the act would negatively affect California. He added that the medical aspects both in the UBO portion and in the general portion, that apply to every fighter, would be things that are good and would contribute to health and safety of the boxers.

Commissioner Dr. De Mars questioned the pregnancy requirement because it is not required in California and should not be anyone else's business. Commissioner Dr. De Mars added that when she was pregnant while competing and her child is fine. She pointed out that she did her research at the Olympic Training Center and reviewed all the articles she could find way back then on pregnancy and competition and there did not seem to be any evidence that competing early in pregnancy had any negative impacts at all. Commissioner Dr. De Mars questioned why that was necessary in the act.

Counsel Kinn stated that couldn't speak to the boxing aspect of it, but there are HIPAA protections, consumer protections, and privacy rights under the constitutions of both federal and state, for our licensing purpose. He added that if a requirement is made for the licensing, then he would think that there'd be an argument that you (the boxer) would be voluntarily waiving those rights in order to participate.

Commissioner Gruwell asked if this would lead to better outcomes for the fighters, but it did sound like it would increase pay around the country and increase the conditions that rise to California's standards. He asked EO Foster if he thought this would bring more events to California? EO Foster stated that it was difficult to say but that it may bring three or four more events per year to California, especially if California was proactive and created a UBO license type.

Commissioner Dr. De Mars asked if the contracts would be exclusive, and that the boxer wouldn't be able to fight for a WBC title. EO Foster stated that was correct.

Commissioner Dr. De Mars asked if the UBO contracts would be for five years? EO Foster stated in California that five years is the limit. Commissioner Dr. De Mars wanted to clarify that there would be nothing that would prohibit the boxer, if they have a good agent or manager, from saying this is the amount I get, that I get a share of the gate or etc. EO Foster said that was correct.



Commissioner Gruwell asked that if the Commission was inclined to support this legislation, what would be the options to show that support? EO Foster stated that the Commission could send a letter or recommend, if requested, for the Chair and EO Foster to testify in support of the bill.

Chair Villegas stated that the Commission's responsibility is for the fairness and safety of the fighters at our events and that he felt this act definitely addressed that.

*Commissioner Gruwell moved for the Commission to issue its support for the Muhammad Ali American Boxing Revival Act (H.R. 4624).*

Chair Villegas asked that events held in California would still support the boxers pension. EO Foster stated the was correct. Chair Villegas asked EO Foster if he could tell the Commission who did support the bill. EO Foster stated that Loyola Marymount University sent a letter in support to Congressman Jack as well as TGB Promotions.

Commissioner Gruwell and Chair Villegas stated that they appreciated all of the public comments.

Commissioner Gruwell requested for the Commission to create a subcommittee and for the subcommittee to report back on its findings regarding the Muhammad Ali American Boxing Revival Act (H.R. 4624).

Vice Chair Dr. Williams asked if this act would remove the Commission's authority to review and approve proposed matches. EO Foster stated the Commission would still hold that authority.

Commissioner Dr. De Mars expressed concern that all of the public comments were in opposition of the act. She added that agreed with Commissioner Gruwell's request to create a subcommittee.

Commissioner Gruwell withdrew his previous motion.

Chair Villegas appointed Commissioner Gruwell and Commissioner Dr. De Mars to a subcommittee and for the subcommittee to report back on its findings regarding the Muhammad Ali American Boxing Revival Act (H.R. 4624) at the next meeting.

## **AGENDA**

### **OPEN SESSION**

#### **1. Call to Order/Roll Call and Establishment of a Quorum.**

Commissioners Hendrickson, Gruwell, Dr. DeMars, Fiore, Chair Villegas, and Vice Chair Dr. Williams attended via video conference.

#### **2. Discussion and Possible Action regarding the Muhammad Ali American Boxing Revival Act (H.R.4624).**

Commissioners Dr. DeMars and Gruwell presented their findings from their subcommittee review. Commissioner Dr. DeMars stated that all people they spoke with were in agreement regarding the health insurance coverage during training and minimum purse per rounds. There was some disagreement amongst the stakeholders they spoke to about the portion of the bill regarding sanctioning bodies and contracts. Commissioner Dr. DeMars explained that often when fighters sign contracts they are relatively young, inexperienced and don't have a lot of resources, and on the other side of the negotiations would be a multi-billion-dollar corporation with a suite of lawyers, and the concern amongst stakeholders is that those individuals may get taken advantage of. The length of the contracts was also a concern of the stakeholders that the subcommittee spoke to. Commissioner Gruwell stated that the stakeholders they spoke with felt that the bill would raise the floor for health standards and pay for boxing around the country.

Vice Chair Dr. Williams asked if the subcommittee came up with any recommendations regarding the pregnancy testing requirement in the bill. Commissioner Gruwell stated that they had not come up with any alternatives, and that they had felt the requirement was a bit inappropriate. Chair Villegas understood the privacy concerns surrounding the issue with requiring pregnancy tests but asked Vice Chair Dr. Williams if there are any issues from a health standpoint. Vice Chair Dr. Williams believed that the rationale may be for maternal or fetal safety, but he believed it is more of a theoretical rationale. He believed there may be some middle ground in an informed consent model, counseling, or voluntary or confidential testing, but does not know if there is an answer.

Commissioner Gruwell explained that the subcommittee did not delve into the issue of length of rounds and that they would defer to EO Foster regarding that issue. He stated that the stakeholders they spoke to were passionate about items that were not addressed in the Muhammad Ali Act in its current or possible future version and that these items could be things the Commission could enact on its own. EO Foster explained that the subcommittee did not look into the 2-minute vs. 3-minute round debate and that California's solution is to do what the contract says; if the female boxers would like to fight 3 minutes then they would be allowed to.

Commissioner Dr. DeMars added that everyone they spoke to agreed that a cost-of-living increase should be included in the bill. Commissioner Gruwell suggested the Commission restate the motions once they hear public comment. He explained that he was going to move to support the bill contingent on an amendment to add a cost-of-living adjustment.

Commissioner Gruwell explained some of the cons the subcommittee came across were due to negative perceptions of UFC and Zuffa and the negative perceptions of the governing bodies. He felt those perceptions tended to be more personal. However, from those discussions arose issues that should be addressed. He did not feel they should be addressed in the house resolution, but possibly by the Commission.



Commissioner Dr. DeMars asked for clarification regarding drug testing in California. EO Foster explained that any time a fighter is licensed in California, the promoter is required to provide the drug testing results to the Commission. There is no requirement if the fighter is not licensed. EO Foster believes the letter writer may be referring to out-of-competition testing like what the UFC uses to monitor their fighters year-round. He noted that once the UFC implemented their testing program the number of fighters using performance enhancing drugs decreased.

The Chair reiterated that boxers would have a choice of whether they want to join a Unified Boxing Organization (UBO) or not. It is not a requirement. Commissioner Gruwell explained that the changes to the industry will not happen instantly and may take years to achieve. He acknowledged that the way the bill is currently written will advantage larger actors in the industry but doesn't see it as a disadvantage for smaller promotions. He also noted that the bill requires UBOs to have a performance facility for fighters to attend, and the subcommittee would like to encourage organizations to partner with local gyms in California so that local fighters would not be at a disadvantage due to their training facility being in a faraway location. He explained that there is no standard on what would qualify as a performance facility and that the Commission could make some recommendations on qualifications.

*Commissioner Gruwell **moved** to support H.R. 4624 contingent upon inclusion of a mechanism for a state-level cost-of-living adjustment to both the minimum purse and minimum insurance requirements to ensure that protections for athletes keep pace with economic conditions over time.*

*Commissioner Fiore **seconded** the motion.*

### **Background**

The California State Athletic Commission has authority under California Code of Regulations, Title 4, Section 384 to designate and recognize contests as California State Championship bouts. The reinstatement of the California State Championship boxing title belt after more than 20 years will reflect the Commission's commitment to honoring the state's boxing heritage and providing athletes with meaningful opportunities for recognition.

On January 16, 2026, a scheduled Super Bantamweight contest at 122 pounds between Jorge Chavez and Manny Flores will take place. Manuel Flores has a record of 20-1-1 with 16 knockouts and Jorge Chavez has a record of 14-0-1 with 8 knockouts. Both of these athletes reside in California and have had a majority of their fights with this Commission.

### **Recommendation**

I recommend that the Commission approve the designation of the January 16, 2026, Jorge Chavez vs. Manny Flores Super Bantamweight contest (122 lbs.) as a California State Championship bout pursuant to California Code of Regulations, Title 4, Section 384.

### **BACKGROUND**

On October 22, 2025, the Commission received a petition to change the decision from Brandon Carrillo. The bout occurred at Thunder Studios in Long Beach on October 10, 2025. At 2:33 in round 2, Chase Whitmer (red corner) stuns Brandon Carrillo (blue corner) with a punch. Mr. Whitmer goes in for a double leg takedown and Mr. Carrillo wraps his arm around Mr. Whitmer's neck to set up for a guillotine choke. Mr. Whitmer escapes the submission attempt, moves around to side control and throws a few punches, then moves to take Mr. Carrillo's back. Mr. Whitmer then positions himself to set in for a choke. At 1:46, Mr. Whitmer begins to move into position to lock in a rear naked choke. At 1:42, Mr. Whitmer appears to have the rear naked choke locked in and starts to bridge. At the same time Mr. Carrillo begins to move his hands to up to pull Mr. Whitmer's hands down in an attempt to escape the submission. Referee Valdimir Matyushenko stops the bout at 3:21 declaring Mr. Whitmer the winner by rear naked choke submission.

### **APPEAL DETAIL SUMMARY**

Mr. Carrillo states in his appeal that when Mr. Whitmer was attempting the rear naked choke that he was consciously defending the submission and was in the process of pulling his hand down when the referee stopped the bout. He states that he was protecting his neck, had his chin down and that the choke wasn't on his neck.

### **EO RECOMMENDATION**

While I believe the referee acted in good faith and made a judgment call that he felt was appropriate at the time, the stoppage of the bout appears to have been premature. Mr. Carrillo did not seem to be in immediate danger or unable to intelligently defend himself. Therefore, I recommend that the result of the bout be changed to a no contest.



### **BACKGROUND**

On November 25, 2025, the Commission received a petition to change the decision from Liza M. Brereton on behalf of boxer, Steven Navarro. The bout took place on November 21, 2025, at Thunder Studios in Long Beach. Referee Thomas (Tom) Taylor warned both boxers in round 1 to watch their heads after a clash of heads. During round 2 both fighters received warnings for fouling. In round 3, at 2:40 Mr. Navarro is knocked down and receives a count by Referee Taylor. At 2:24 in round 3, Mr. Navarro and Mr. Mendoza clash heads causing both fighters to suffer a laceration. At 2:20, Referee Taylor calls a timeout and brings Dr. Diaz onto the ring apron to check on the laceration that Mr. Mendoza received. Dr. Diaz examined Mr. Mendoza and determined that he could continue. As the round continued and Mr. Mendoza received more punches, the laceration opened up more and began bleeding down Mr. Mendoza's face. Referee Taylor called another timeout at 1:05 for Dr. Diaz to examine the laceration on Mr. Mendoza. Dr. Diaz determined that Mr. Mendoza could continue the round. During the break both athletes went to their corners for their one-minute break. Dr. Diaz observed Mr. Mendoza from the ring apron during the break. With 10 seconds left in the break, the Inspectors instructed the seconds to leave the ring. The bell rang for the start of round 4 and Referee Tom Taylor called a timeout. Mr. Navarro was sent to a neutral corner, and Mr. Mendoza was brought over to be examined by Dr. Diaz. Dr. Diaz examined the laceration and informed Referee Taylor that he felt the bout should be stopped. Referee Taylor called a stop to the bout and instructed the judges to score the round.

Per California Code of Regulation, title 4, section 339 (b) unintentional fouls that cause bouts to be stopped after the start of the 4<sup>th</sup> round will be decided on the judges' score cards. Referee Taylor followed the California rules for professional boxing and per the judges scores, Mr. Mendoza won the bout unanimously via technical decision. However, if this fight would have been under the Association of Boxing Commissions Unified Rules, the bout would have been ruled a no contest as four completed rounds are required.

Dear Mr. Foster and Members of the California State Athletic Commission:

On behalf of my client, Steven Navarro, I respectfully submit this Petition for Change of Decision pursuant to 4 CCR § 368. This Petition is supported by: (1) the facts and arguments set forth below; (2) the full bout video and except videos provided via link in the email transmitting this Petition; (3) an image of Mendoza's injury during the second timeout in the third round, attached as Exhibit 1; (4) post-fight written statements made by Jesse Mendoza's trainer, José Urióstegui Jr., attached as Exhibit 2; and (5) the forthcoming note of support from Top Rank's General Counsel, Jeremy Koegel.

**1. Factual Background**

On November 21, 2025, Steven Navarro competed in a Super Flyweight bout scheduled for eight rounds against Jesse Mendoza at Thunder Studios in Long Beach, California. The referee in charge was Thomas Taylor, and the ringside physician was Dr. Danial Diaz. Both Mr. Taylor and Dr. Diaz are highly respected by the boxing profession, including by Mr. Navarro and me. This Petition does not impugn their expertise or professionalism, but rather respectfully challenges certain pivotal decisions made during the course of the bout.

**a. The Third Round**

Starting seven seconds into the third round, Mendoza held Navarro's right arm with his left hand while repeatedly hitting Navarro with his other hand in violation of 4 CCR 337(3). Shortly thereafter, Navarro went down and it was scored as a knockdown.

**i. Timeout and Ringside Physician Examination #1**

With 2:24 left in the third round, Referee Taylor called an accidental headbutt and then called timeout. He immediately directed Mendoza to be examined by Dr. Diaz. There was a significant laceration above Mendoza's right eye, with substantial bleeding into the eye and down



his face and chest. After the examination, Dr. Diaz and Taylor permitted the bout to continue. As the round progressed, Navarro landed numerous heavy shots, and Mendoza's offensive output decreased markedly.

**ii. Timeout and Ringside Physician Examination #2**

With 1:04 remaining in the third round, Taylor again called timeout due to the wound and severe bleeding. (Image at Exhibit 1). Taylor directed Mendoza to a second doctor's examination, during which Dr. Diaz attempted to assess Mendoza's right eye vision by covering the left eye and holding up fingers. Video footage shows Mendoza noticeably moving his head to one side to obtain a line of sight, suggesting a lack of sight through the right eye. After the fight, Mendoza's trainer wrote on Instagram that Mendoza was not "able to see at all," and that "the eye was fully cover in blood," consistent with what is visible on the video. He continued that "anyone who's had a cut knows you can't see anything when the blood drops in the eyes." (Exhibit 2).

Despite two timeouts being called in the third round for medical evaluation and although the injury and bleeding only worsened, the bout was not stopped during or immediately after the round. In the remaining 30 seconds of round three, Navarro landed several clean blows while Mendoza continued to bleed profusely.

**b. Mendoza's Injury Did Not Improve While Dr. Diaz Observed Him During the Break Following the Third Round**

Immediately after the bell signaling the end of the third round, Dr. Diaz proceeded to Mendoza's corner and leaned over the ropes to observe the cut and bleeding, which did not improve. Dr. Diaz remained in Mendoza's corner during the break. Mendoza's corner did not appear to take significant steps to close the wound or stop the bleeding.

**c. The "Fourth Round" Bell Was Sounded Before the Ring Was Cleared**

Although both a CSAC representative and Mendoza's trainer remained inside the ring beyond the one-minute break, the bell for the fourth round was nevertheless sounded, contrary to 4 CCR § 334, which prohibits anyone other than the contestants and the referee from being in the ring during the progress of a round. Approximately five seconds passed before the two men left the ring, underscoring that the fight was expected to be stopped immediately.

**d. The Bout Was Stopped Without Further Boxing or Medical Assessment**

Once Taylor directed the two men out of the ring, he immediately called a third timeout without ever permitting the boxers to leave their corners to fight. He instructed Mendoza to approach Dr. Diaz. However, as shown in the videos, before any further medical assessment occurred, Taylor can be heard in the video stating, "We're still stopping the fight." There was no examination of Mendoza by Dr. Diaz in the "fourth round" before the fight was stopped.

Taylor then asked the judges, "what round do we got?" When told it was the fourth round, he instructed the judges that the bout would be determined by the scorecards. The judges scored the bout 39-38, 39-37, 39-38 for Mendoza. Two of the judges scored the third round 10-9 for Mendoza despite the scored knockdown, reflecting Navarro's dominant performance following it.

Under 4 CCR §§ 339 and 340, when a bout is stopped due to injury in the fourth round or later, the outcome is determined by scoring the completed rounds and the round during which the referee or ringside physician stopped the bout. This rule anticipates that there generally will be boxing to judge in the round in which the bout is stopped. Such was not the case here. Because there was no boxing in the purported “fourth round,” it was scored 10-10. The outcome of this fight was determined solely on three rounds of actual competition despite the lack of any additional medical evaluation in that round.

## **2. Grounds for Petition to Change Decision**

### **a. The Fight Should Not Have Been Treated as Ending in the “Fourth Round” for Scoring Purposes**

Pursuant to 4 CCR § 345 Referee Taylor had the power to stop the fight at any point due to Mendoza’s injury, including during the break. The bout should have been stopped before the fourth round bell.

#### **i. 4 CCR 334 Was Violated by Allowing Unpermitted Personnel to Remain in the Ring When the “Fourth Round” Bell Was Sounded**

4 CCR § 334 precludes anyone other than the contestants and the referee from being in the ring during the progress of a round. This rule was violated because, as shown in the videos, a CSAC representative and Mendoza’s trainer were both inside the ring when the fourth round bell was sounded and remained in the ring for several seconds afterward. Their presence, and the fact that the bell was rung despite it, further reflects that a stoppage was imminent.

#### **ii. The Bout Should Have Been Stopped Before the Fourth Round Bell Because there Were Two Medical Evaluations in the Third Round, the Injury Visibly Worsened During the Third Round, and it Did Not Improve at the Break**

The injury visibly worsened over the course of the third round as Navarro landed clean shots. Mendoza was directed to the ringside physician twice during the third round because of the significant laceration and substantial bleeding that was impairing his vision. Indeed, the video shows Mendoza having difficulty during the physician’s vision assessment and moving his head to attempt to pass it. Mendoza’s trainer’s public statement after the bout confirms that the eye was covered in blood and that Mendoza could not see out of it. (Exhibit 2). Therefore, the bout should have been stopped during or at the end of the third round.

Furthermore, during the one-minute break following the third round, Dr. Diaz remained at Mendoza’s corner observing the injury and Taylor remained observant. There was no improvement, yet the decision to stop the bout was delayed.

#### **iii. The Bout Should Have Been Stopped Before the Fourth Round Bell Because there was No Competition Nor Any Medical Assessment in the Purported “Fourth Round”**

The stoppage was unduly delayed because after the fourth round bell, the boxers never left their corners and there was no further medical examination of Mendoza before the fight was finally

stopped. Although there are circumstances under which a corner should be afforded an opportunity to attempt to close a cut and stop bleeding between rounds, that approach was not warranted here. It is especially problematic that the bout was permitted to pass the fourth round bell because:

- Mendoza had already undergone two in-round medical evaluations for the same injury;
- the condition deteriorated despite those evaluations;
- there was no indication that additional time would lead to improvement;
- allowing the fourth round bell to ring served no legitimate purpose because there was no competition permitted and there was no further medical examination conducted;
- non-permitted personnel were in the ring at the beginning of the “fourth round,”
- there were significant consequences to delaying the stoppage because the bout outcome was then determined on only 3 rounds of boxing.

Under these circumstances, a stoppage during the third round, at the end of the third round, or between the third and fourth rounds would have been consistent with the authority granted under 4 CCR §§ 345. Instead, the bout’s outcome rested on only three rounds, even though the conditions leading to the stoppage had arisen within the third round itself and as explained above, permitting the fourth round bell to ring in this fight served no legitimate purpose. Instead, it led to unjustified consequences.

The scoring framework in 4 CCR §§ 339 and 340 presumes that the round during which a bout is stopped will include actual competition for the judges to evaluate. Here, however, there was no such opportunity because the stoppage occurred immediately after the bell, without action in the round. Perhaps even more significant is the lack of any additional examination that might justify treating the stoppage as having occurred during the fourth round. Therefore, the rationale of not stopping the fight before the fourth round bell in order to provide additional time for a ringside physician’s examination was not present in this bout.

Treating the stoppage as occurring “in the fourth round” under these particular circumstances was incorrect, in violation of the rules stated herein, and the outcome should be changed. The decisive events all took place during the third round and did not change between the end of the third round and the sounding of the fourth round bell. The outcome was therefore influenced more by the timing of the bell than by in-ring action.

### **3. Request for Corrective Action**

For these reasons, and in alignment with the letter and the spirit of the applicable regulations, Mr. Navarro respectfully requests that the Commission change the outcome of the bout to a technical draw or to a no contest.

### 1. ABC Unified Rule (2): Sole Arbiter

The Referee is the sole arbiter of a bout and is the only individual authorized to stop a contest.

#### CA Rule §339(a) §340(a):

Referee and Doctor have equal powers to stop a fight

### 2. ABC Unified Rule (9): Knocked Out of Ring

A boxer shall receive a twenty **(20) second** count if the boxer is knocked out of the ring. The boxer is to be unassisted by spectators or his/her seconds. If assisted by anyone, the boxer may lose points or be disqualified with such a decision being within the sole discretion of the referee.

#### CA Rule §351:

A Boxer who is knocked out of the ring will receive a "Mandatory 8 Count" and if up on his/her feet by the count of 8, shall receive "Reasonable Time" to return to the ring and may be assisted by anyone.

### 3. ABC Unified Rule (10): Saved by The Bell

A boxer who has been knocked down cannot be saved by the bell in any round.

#### CA Rule §349:

A Boxer who has been knocked down may be saved by the bell in the final round.

### 4. ABC Unified Rule (A)(2): Intentional Foul-Point deduction

If an intentional foul causes an injury and the bout is allowed to continue, the referee shall notify the authorities and deduct two **(2)** points from the boxer who caused the foul. Point deductions for intentional fouls will be mandatory.

#### CA Rule §338 (b):

Intentional Foul: Minimum 1 Point or More at Referees Discretion.

### 5. ABC Unified Rule (A)(3): Intentional Foul - Fight Continues

If an intentional foul causes an injury and the bout is allowed to continue, and the injury results in the bout being stopped in any round after the fourth (4th) round, the injured boxer will win by **TECHNICAL DECISION** if he is ahead on the score cards; and the bout will result in a **TECHNICAL DRAW** if the injured boxer is behind or even on the score cards. Four (4) rounds are complete when the bell rings signifying the end of the fourth round.

#### CA Rule §339(b):

Due to Intentional foul: If a Bout is stopped once the Bell has rung to start the 4th round it will go to the scorecards.

The Fighter, who is ahead at the time, shall win by Technical Decision, and if the fight is even on the scorecards, it shall be declared a Technical Draw.



#### **6. ABC Unified Rule (B)(1): Accidental Foul**

If an accidental foul causes an injury severe enough for the referee to stop the bout, the bout will result in a **NO DECISION** if stopped before **four (4) completed rounds**.

##### **CA Rule §339(b):**

Due to accidental fouls: Bouts Stopped **before** the start of 4<sup>th</sup> round will be declared a Technical Draw. Bouts stopped **after** the start of the 4<sup>th</sup> round will be decided on the judges' score cards.

#### **7. ABC Unified Rule (13): Low Blow**

A fighter who is hit with an accidental low blow must continue after a reasonable amount of time but no more than five (5) minutes, or he/she will lose the fight.

##### **CA Rule §339(a):**

On an accidental Low Blow, the injured Boxer has "Reasonable Time" to recover (the bout may be stopped just like an injury from any other accidental foul)



## **Statement Regarding Bout on November 21, 2025**

**Fighter: Jesse Mendoza vs. Stephen Navarro**

**Location: Thunder Studios, Long Beach, California**

This statement is submitted in response to the request for appeal regarding the bout held on November 21, 2025, between Mr. Stephen Navarro and Mr. Jesse Mendoza. The information below reflects my medical assessments and clinical decision-making as they occurred in real time during the event.

During the contest, I was requested by Referee Thomas Taylor to evaluate Mr. Mendoza on three separate occasions. Two timeouts occurred during the third round, and a third evaluation was requested at the beginning of the fourth round.

---

### **Timeout #1 – Early Third Round**

Referee Thomas Taylor called a timeout and requested that I assess Mr. Mendoza. On evaluation, I identified a laceration above the right eyebrow. At that time, the laceration was linear with bleeding running down the side of his face. Given these findings, I determined that it was safe for Mr. Mendoza to continue, and the bout resumed.

---

### **Timeout #2 – Late Third Round**

Toward the end of the third round, Referee Thomas Taylor again requested a medical evaluation. The laceration had increased in size, and active bleeding was now present around and into the right eye.

Mr. Mendoza was asked directly whether he could see from his right eye, and he affirmed that he could. To confirm functional vision, I performed a finger-count assessment three times, presenting one finger, then two fingers, then one finger again, all while covering his left eye. Mr. Mendoza accurately identified the number of fingers in the correct sequence on all attempts.

Given these findings, I determined at that moment that it remained medically appropriate for the bout to continue.

---

### **Between Rounds 3 and 4**

During the break between rounds, I independently approached Mr. Mendoza's corner to observe the cut. This was done of my own accord; no timeout was called by the referee, and my actions did not interfere with the corner's time or coaching.

---

### **Timeout #3 – Beginning of Fourth Round**

Immediately at the start of the fourth round, Referee Taylor called a third timeout and requested another evaluation of Mr. Mendoza. Upon assessment, I noted a clear change in the morphology of the laceration, as well as persistent bleeding that the corner was unable to control.

Given the evolution of the injury and the increased risk to Mr. Mendoza's overall safety, I determined that it was not medically safe for him to continue. Based on this assessment, I advised that the bout be stopped.

On October 30, 2025, USA Boxing sent a letter to their members to clarify their policy regarding USA Boxing athlete members competing in events not sanctioned by USA Boxing. Their policy, per rule 8.2 of the USA Boxing rulebook is, “USA Boxing athlete member shall NOT box in any boxing competition that is not sanctioned under USA Boxing”. This includes participation in MMA, Kickboxing, Muay Thai and any other such sport. The letter also goes on to state that the above rule applies to “sparring events” or such activity where competition or sparring is used for entertainment.

The letter goes on to state USA Boxing's rule on non-athlete members participating in events not sanctioned by USA Boxing. Their policy per rule 1.5, item 4 of the USA Boxing rulebook is, “non-athletes are allowed to participate in events sanctioned by State Athletic Commissions or take place on Military Bases and Native American Reservations, but USA Boxing's insurance doesn't cover these events.”

This letter has raised some concerns within the amateur delegations, and I felt it was necessary to bring this to the attention of the Commission for review and discussion. The letter is included in the meeting materials.

Good morning USA Boxing members,

Over the last several weeks, we have received numerous inquiries regarding USA Boxing's policy surrounding the participation in events not sanctioned by USA Boxing. We understand the confusion, as athlete and non-athlete members have separate guidelines. This letter serves to clarify such policies and provide guidance on approved participation as active USA Boxing members.

**ATHLETE MEMBERS:**

USA Boxing athlete members CANNOT participate in any combative sporting event not sanctioned by USA Boxing, per **Rule 8.2** of the USA Boxing rulebook, "[a] USA Boxing athlete member shall NOT box in any boxing competition that is not sanctioned under USA Boxing."

This includes participation in MMA, Kickboxing, Muay Thai and any other such sport.

This rule above also applies to "sparring events," or any such activity where competition or sparring is used for entertainment. USA Boxing defines sparring as:

*"A form of training where two boxers simulate the act of boxing in a controlled environment, under the guidance of a USA Boxing registered coach. Sparring is to be used exclusively for training purposes, at a training facility and during business hours. Sparring as entertainment is prohibited."*

Participation in unapproved/unsanctioned sparring events is considered a violation of **Rule 8.2**. Please refer to the chart below to distinguish What USA Boxing considers an event (which must be sanctioned) versus sparring. For more information, please refer to the USA Boxing sanction manual, located [HERE](#).

Sanction/Event	Sparring / Other

### NON-ATHLETE MEMBERS:

USA Boxing non-athlete members are allowed to participate in certain events not sanctioned by USA Boxing. Per **Rule 1.5, Item 4**, non-athlete members may participate in the following:

*“Non-Athletes are allowed to participate in events sanctioned by State Athletic Commissions or take place on Military Bases and Native American Reservations, but USA Boxing’s insurance doesn’t cover these events.”*

Examples of this are:

- USA Boxing registered coaches who coach professional boxers in events directly sanctioned by a state/tribal athletic committee.
- USA Boxing members who work as an official for an event sanctioned directly by the state/tribal athletic commission.
- USA Boxing members who coach or officiate at a United States service academy boxing event.

USA Boxing non-athlete members found to participate in events not sanctioned by USA Boxing or those not listed in **Rule 1.5, Item 4** are subject to USA Boxing’s disciplinary policy, per **Rule 1.5**:

*“Any boxer, coach or official who participates in an unsanctioned or unregulated combat sport is ineligible to participate in competition as an athlete or non-athlete member of USA Boxing. An appeal may be considered through USA Boxing’s grievance and complaint process.”*

USA Boxing does **NOT** recognize organizations approved by state athletic commissions, by proxy. As such, participation in such events is a violation of **Rule 1.5** of the USA Boxing rulebook. Please refer to the chart below regarding participation.

## RATIONALE

USA Boxing's top priority is the health and safety of our members, participants, and attendees. Unapproved participation places many innocent lives at risk. USA Boxing put these rules in place to safeguard and mitigate much of the risk involved in boxing. It's common for unsanctioned or unapproved events to operate at a lower standard of safety than USA Boxing.

Secondly, we recognize combative sports have evolved and cross disciplinary training is more prevalent than ever. However, promotions and commissions have yet to develop a centralized database to report injuries. USA Boxing safeguards our members by placing them on a 30 day medical hold when we discover any form of unapproved participation. This ensures the boxer doesn't exacerbate any unreported or undiscovered injuries that may have taken place at an outside event.

Lastly, non-athlete members that encourage or facilitate participation of USA Boxing athlete members in non-USA Boxing events are in violation of the USA Boxing Non-Athlete Code of Conduct and subject to USA Boxing's disciplinary policies:

3. I will not engage, nor encourage any boxer to engage, in any behavior which would endanger the health, safety or well-being of any boxer, coach, official, volunteer, spectator or USA Boxing staff member.
12. I will put the safety of the boxers first when agreeing to or determining matches.

USA Boxing strives to preserve the health and safety of our members through equitable and transparent governance. We thank you for your dedication and support of Olympic-style boxing and USA Boxing.

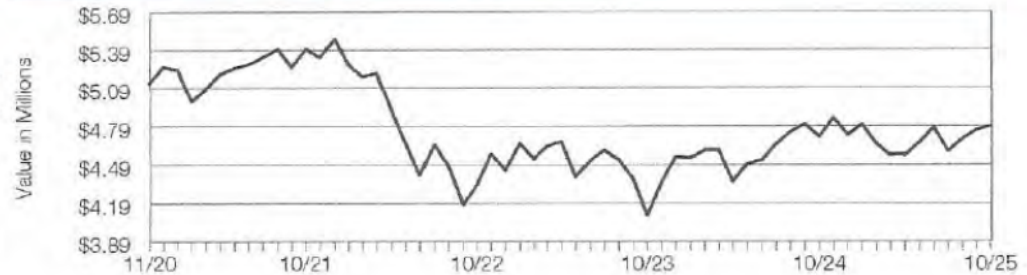

**1. CAMO SAFETY AND SUSPENSION REPORT:**

We are pleased to report that there have been no injuries of heightened concern since the last CAMO report on September 8, 2025. This is a testament to our collective focus on athlete safety. Attached please find our injury and suspension list for your review (Exhibit 1).

**2. FINANCIAL REPORT:**

CAMO's reserve accounts continue to maintain appropriate levels in anticipation of the seasonal slowdown we experience annually during the holiday season. We remain within all recommended financial ranges. CAMO's fiscal year closes on May 31, 2026, and tax preparations will be prepared accordance with all requirements.

**3. 2025 AT A GLANCE**

2025 was a tremendous year for the amateur mixed martial arts community under CAMO. We regulated 93 events across the state, licensing well over 1,000 athletes and overseeing more than 1,000 bouts. We are grateful for another year marked by an exceptional safety record.

Our California athletes continue to lead on local stages and at the highest levels of the sport. The "pathway to the pros" starts here in California for both athletes and officials, and we are proud to consistently develop elite-level talent on both fronts.



This success does not happen without preparation. CAMO conducted quarterly trainings, most led by CSAC Chief Inspector Mark Relyea. We deeply appreciate the continued support of CSAC inspectors and referees, whose mentorship and instruction strengthen our entire community. 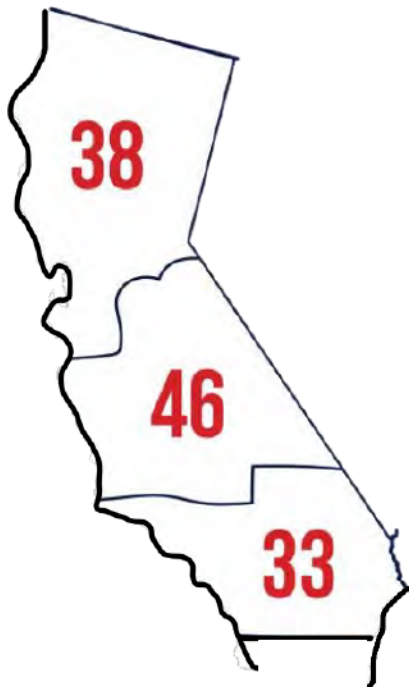

Please accept this as part of USA Boxing's reporting requirements for the period of April 2025 through June 2025, to be presented during the California State Athletic Commission Meeting for quarter two of 2025.

## I. Geographic Information

USA Boxing is comprised of 57 distinct regions across the United States, referred to as Local Boxing Committees (LBCs). California represents four of those regions.



### **Northern California – LBC 38**

This represents San Jose, Sacramento and the surrounding areas.

### **Central California – LBC 46**

South of Sacramento, down to Bakersfield.

### **Southern California – LBC 33**

South of Bakersfield down to Carlsbad.

### **California Border – LBC 44**

#### WAKO USA-Kickboxing Current Events:

The WAKO World Championships are being held in Abu Dhabi from November 24 -29, with 5 continents, 83 countries, and 1973 athletes competing in a series of events over six days. 41 participants, including 6 from California, are in attendance, representing the U.S.A. We wish them the best of luck and look forward to sharing each of their experiences as we anticipate bringing home the Gold!

We are pleased to report that Parakickboxing also made its debut in the World Games with fighter Michael Crow of Arkansas taking the Silver Medal. This is a significant step forward, as WAKO USA values inclusiveness among its top priorities.

#### California Events and Achievements: September - November 2025

In this quarter, 3 of 5 scheduled full-contact events were held across California from September 1 to November 30, featuring a total of 34 bouts and **110 rounds**. One medical transport was reported due to possible head trauma after a stoppage. The injury was later reported that evening as a broken orbital, with no further treatment needed. The fighter was treated and released the following morning after observation. 8 suspensions were issued, **5 TKO or referee stoppage, and 3 due to possible injury, as recorded on BoxRec.**

All fighters and coaches are informed of the format and rules for participation, with emphasis that the event is for practice purposes only and will not affect their win-loss records.

All officials are required to complete an approved certification program, followed by hands-on event training and mentorship, to serve as officials for all USA Kickboxing-sanctioned events, in accordance with the WAKO USA Kickboxing delegation issued by the state of California. Continuous training must be completed at least every 6 months within each year, along with Licensing at, [RSportz World Association of Kickboxing Organizations](#).

The recognized program for USA Kickboxing in California and utilized across the U.S. is Stellar Universal Officials LLC (S.U.O.), conducted by Dan Stell, a 43-year active International Referee (40-year CSAC Referee and Judge).
